## **1. GENERAL PROVISIONS**

- 1.4. In matters not regulated by these Terms and Conditions, the following provisions apply:
  - 1.4.1. Act of 18 July 2002 on the provision of electronic services (Journal of Laws No. 144, item 1204, as amended);
  - 1.4.2. Act of 30 May 2014 on consumer rights (Journal of Laws 2014, item 827);
  - 1.4.3. Act of 23 April 1964, Civil Code (Journal of Laws No. 16, item 93, as amended);
  - 1.4.4. and other relevant provisions of Polish law.
